**Subject:** [WWC Delegates] Warrant article, motion and ballot question

*Attached is a draft warrant article and motion for town meeting and a ballot question for a possible vote on overriding Prop 2 1/2. It is to replace the version sent to towns by MBI, which eliminated from the original draft the reference to towns working through their MLP coop. This version restores that language so as to make it clear that indeed it is the intention of the towns working on the regional effort to act through WiredWest or its successor MLP coop. It has been vetted by Rick Manley, municipal bond counsel of the firm Locke Lord Edwards, who produced the original draft. Unless I hear that you prefer to deliver this information to your Select Board members yourself, we will be sending it directly to them. It is important that they receive it immediately.*
