

Autumn Tidings from the Select Board

Your Selectboard members. Rita Farrell, Melissa Makepeace O'Neil, and Eric Stocker, have been busy tending to town business over the last few months. We continue to hold our bi-weekly meetings as hybrid meetings with the Select Board in person at the Town Hall, and townspeople can either be in person at Town Hall or join the meeting via Zoom. Our meetings are generally on Tuesday evenings at 6:00 – please check the town calendar at www.shutesbury.org for any updates and the meeting agendas.

The Select Board has appointed two new committees in the last few months. First, the Lake Wyola Stormwater Task Force will be looking at the issues with stormwater on both public and private property bordering Lake Wyola. Runoff into the lake poses serious concerns for the quality of the lake and this group will be making recommendations to the Town.

The Lake Wyola Boating and Safety Review Committee is examining the current bylaw that governs recreational activ-

ity on the lake to examine whether any changes are needed to the current bylaw and also to look at ways to improve enforcement of the bylaw.

Meetings of both these committees are open to the public and posted on the town calendar on the website. A large crowd of enthusiastic townspeople and state and federal legislators were on hand in early August to celebrate the groundbreaking for our new library. Construction is well underway and we are all looking forward to a ribbon cutting next year.

Town staff news: We are pleased to announce that Dave Grenier has been appointed as the new Highway Superintendent upon the retirement of Steve Sullivan. and Abby Hernandez, a new town resident, has been hired as the Administrative Secretary for the Select Board. Matteo Pangallo has been hired as the new Land Use Clerk for the Planning and Zoning boards. And the Shutesbury Eleentary School welcomed Anne Magill Diaz as the new principal.

The town has been participating in a study by the Collins Center looking at the feasibility of regionalizing fire depart-

ments in the towns of Shutesbury, Wendell, Leverett and New Salem. Phase I of this study is complete and we have applied for funding to complete the next phase of this study, which will look at implementation of shared fire services.

The town was very pleased to receive a \$222,000 grant from the Municipal Vulnerability Program (MVP) which will cover the cost of the solar panels and battery backup for the new library.

Oversight of the gasoline leak and the PFAS contamination from the Shutesbury fire station continues, and we are working closely with our licensed site professionals from Tighe & Bond and the State's Department of Environmental Protection to address these serious issues.

And last but not least, there will be a Special Town Meeting on Tuesday, November 19 at 6 pm at the Shutesbury Elementary School. The warrant for this meeting will be finalized in the next few weeks, but as of now we know that there will be articles from

- the Community Preservation Committee
- a citizens' petition
- an article to cover funding for the library assistant.

What's On The Ballot: The town website is your first stop for information, instructions and updates about the Novem-

ber 5 Election. In addition to voting on candidates for federal, state, and county offices, there are 5 questions on the ballot. You can find more information about these questions in the red booklet that the Secretary of the Commonwealth mailed to every household in September. Additional copies of the red booklet are available at Town Hall and on the town website.

When Can I Vote: It is up to you the voter whether you would like to vote by mail or in person. Mailed ballots start going out to voters in early October. If you want to vote by mail and are not already signed up, you can submit an application online or by filling out a paper application and submitting it to the Town Clerk Office. Links and forms are available at Town Hall and on the town website. The deadline to apply for Vote by Mail is October 29^t by 5pm, but the earlier the better.

TIP: Use the TrackMyBallot portal on the Secretary of the Commonwealth's website to check whether or not you are already signed up for Vote by Mail, when your ballot is mailed to you, and when your voted ballot has been received by the Town Clerks Office (congratulations on voting!).

If you prefer to vote in person, no worries! In person Early Voting will take place from October 19 until November 1. In Person Early Voting Schedule:



ECAC Updates

The Shutesbury Energy and Climate Action Committee (ECAC) is hard at work; there are projects underway and others planned to address climate and energy issues for the town.

Community Choice Aggregation (CCA). Currently, residents using electricity from National Grid pay for two functions – the supply and distribution of electricity. Community Choice Aggregation is a state program to allow changes to the source of electricity (supply); distribution will still be

through National Grid. There are multiple goals of aggregating Shutesbury residents' electricity, among them lower prices (sought but not guaranteed), having electrical sources that are "greener" than state government requires, and more stable pricing (rates are locked in for the life of a contract).

At the 2023 Annual Town Meeting, the town voted to begin the process of getting electricity for residents thru CCA. Following that vote, the town secured the services of Colonial Power Group, as our CCA broker. Many other small towns in western Mass use Colonial and we have been impressed so far. The next step in the process will be to get a draft proposal of an aggregation plan for Shutesbury from Colonial. This will be reviewed by the town - details to follow. The intent of ECAC has been to offer three options for residents: electricity sourcing that makes electric prices cheaper than National Grid; sourcing that is "greener" than the state requirement, and sourcing that minimizes the use of forested land for solar. Residents can pick which plan they like. While this is ECAC's hope, we need to find out what is presented to us and then proceed accordingly.

If all goes smoothly with state agency approvals, residents could begin selecting their new electrical service in spring 2025. Prior to this time, ECAC will make sure that residents have enough information to make an informed decision. It is also important to note that while CCA may be attractive to many residents, anyone who wants to keep what they have as an electrical source can —

you opt-out. For those who have a solar system which allows you to earn net metering credits, as long as the account holder is receiving supply from National Grid, they are able to participate in the aggregation program and will continue to receive net metering credits from the utility. Net metering will work in the same way as before you joined the CCA program. For those receiving electricity from a third party through a contractual arrangement, for example ClearEnergy, there could be a penalty for ending the contract early - figuring this out will require some work with our broker, Colonial.

Climate Leader Community **Program.** In the past year, Mass. state government rolled out a new program, the Climate Leader Community Program that is intended to provide "tools and resources to help municipalities reduce emissions by electrifying nonelectric energy uses and maximizing the efficiency of buildings and transportation." The program is voluntary. ECAC has voted to pursue this option and seek support from residents. Being a Climate Leader Community will be beneficial to the Town, likely opening up new opportunities (including state grants) for us to become more "climate ready."

There are six things that a municipality must do to become a Climate Leader Community. Shutesbury already has done two – we have Green Community status (a previous state program) and we have a dedicated climate and energy committee – ECAC. Three of the other things ECAC hopes to bring to a 2025 town meeting for

consideration. These are:

- 1) a resolution that the town will work to be net zero by 2050, assuming state and federal financial assistance
- 2) a policy that, when financially feasible, the town will buy zero-emission vehicles first before other options; and
- 3) that the town will adopt a Specialized Building Code that is more proactive regarding climate and energy building than the 2023 Stretch Code we already must adhere to as a Green Community. The Specialized Code only impacts new construction or large/significant renovations (more than 1,000 sq feet or 100% of conditioned area).

The final step will be to develop a Decarbonization Roadmap, a plan for the town to achieve our goals. This will require a state grant which is not yet available. While this process may sound complicated, ECAC believes it is do-able and beneficial for our town.

Join Us. ECAC is looking for a fifth member to round out the committee. If you are interested in climate and energy issues as they pertain to the town, this might be the committee for you. Anyone interested should email Michael at ecac@shutesbury.org. We ask that interested individuals attend at least one meeting to get a sense of how we work and what we do.

Ask Us. ECAC has four members – Gail Fleischaker, Nate Heard, Isaac Goldstein, and Michael DeChiara (chair). As these initiatives progress, ECAC will host information sessions. There is currently information on these two initiatives on the ECAC webpages.

Together, we are hoping the Town can make a difference for residents and do our part for the planet.

Shutesbury Finance Committee Report

On April 27, 2024 we held our first indoor Annual Town Meeting since the pandemic in 2020. The voters passed a budget for FY 2025 totaling \$7,208K, an increase of \$309K, or 4.5% over last year's budget. In the Fall of 2023, the Finance Committee, working with our Town Administrator and Department Heads, requested a "level services" budget. This is different than "level funding" in that it is assumed that to provide the same services each year, it is likely that the costs of those services will increase. In September, 2023, we wrote to the department heads with this request and set up a schedule of meetings prior to creating a final budget.

Over the year, we met with each department head to go over their level services budget for FY 25 including any proposed changes in staffing and/or operations. The Capital Planning Committee looked at the requested Capital expenses.

Highlights from the FY 2025 Budget:

- The voters of Shutesbury voted to pass a total budget of \$7,208K which was a total budget increase of \$309K or an increase of 4.5% over FY 2024.
- As per Mass General Law, the budget must balance the expenditures and the revenue. The Revenue

- sources come from Residential Taxes (\$5,384K); Commercial/Industrial/Personal Property Taxes (\$327K); Estimated Net State Aid (\$747K; PILOT (Payment in Lieu of Taxes (\$340K); Local Receipts (\$320K); WPAT Septic Betterment Loan (\$70K); Free Cash for Temporary Costs (\$70K).
- Residential Taxes make up the bulk of our revenue at 74.7% of the total.
- On the expense side, Education makes up 59.0% of the total budget. Other major expenses include Fire/Police; Highway/Public Works; General Government; Retirement, Unemployment, Medicare, OPEB; Health Insurance for town employees.
- Raises for Town Employees were a total increase of \$36K. This increase is based on the formula developed by the Personnel Board with the goal to keep our town's salaries competitive in Franklin County.
- The largest increases in the Town's Budget is reflected in the Elementary School Budget (increase of 5.8%) and the Regional School Budget (increase of 5.9%). The Elementary School Budget increase was driven by mandated educational needs as well as the loss of **ESSER** Funds that were from 3 stimulus bills from the Federal Government passed between 3/2020 and 3/2021 during the pandemic.
- The Regional School Budget increase reflects many hours of work on the part of the four towns, the regional school committee

and superintendent to create a budget that would maintain a high level of education while also facing significant budgetary shortfalls. Compromise was found with the modified statutory method being put aside for the year in order that none of the four towns have an unreasonably high increase in their assessment for FY 25. Members of our Finance Committee have met in September, 2024, with the new superintendent, Dr. Xiomara Herman (aka Dr. Xi) to begin to bring our town's concerns forward as well as to advocate for having the four towns in the region meet together before the usual meeting in December. The four towns met on September 28, 2024 to begin the budget process for FY26.

- The Finance Committee, in conjunction with the Department Heads and our Town Administrator and Capital Planning Committee developed a plan to fund several items. These included a Police Pickup Truck (\$71K), a generator for the Highway Department (\$25K), Police **Department Body Cameras** (\$12K); A program for Gravel Road repairs and upgrades (\$12K), Storage container for the Highway Department (\$5K). These items will be paid for from the town's Free Cash and Capital Stabilization accounts.
- \$70K from Free Cash was used for non-permanent school costs (\$40K) and to gradually restore the funding of the building repair line item

- (\$30K) into the operating budget.
- At the end of Town Meeting the projected remaining total of our Free Cash is \$1,363K.

We are beginning the process of preparing the FY 2026 budget. A letter to Department Heads was sent out with a request for level services budgets. A tentative schedule to meet with Department Heads has been started. The Finance Committee's meetings are on the Town's Meeting Calendar and the public is welcome to attend.

From the Assessors Department

Real Estate Tax and Community Preservation Act (CPA) Surcharge Exemptions:

Shutesbury offers a variety of real estate tax exemptions for low-income seniors, veterans, and blind taxpayers. Lowincome property owners of any age may qualify, based on income, for exemption from the CPA surcharge. Explanatory guides and application forms are available to read at Shutesbury.org on the Assessors' department webpage. Applications were sent during the summer to all property owners who received partial exemption from their taxes in the previous year. If you did not get an application, or have never applied before, and you wish for more information, please contact the Assessors office. Applications are due on April 1, 2025.

Additionally, Shutesbury offers a "Means-Tested" exemption for seniors, which is based primarily on qualification for the "Circuit-Breaker-Form CB" on the Massachusetts Income Tax return, though high assets may disqualify applicants from this local option. Seniors who submit

Form CB for credit on their 2024 Massachusetts Income Tax Return are invited to contact the Assessors' office for more information about submitting an application in Shutesbury for the Means-Tested Exemption. Those applications are due on August 31, 2025.

Notice to Chapter 61 Applicants:

New or renewal applications for Chapter 61 classification for FY 26 (July 1, 2025 to June 30, 2026) are due on December 1, 2024. Chapter 61, 61A and 61B property owners enjoy the benefit of lower taxes and have the obligations of Chapter 61 land classification ownership. A very helpful property owner guide is available at

Note from the Town Collector

Dear Shutesbury residents:

With the arrival of the fall, the second quarter of your real estate and personal property taxes have been mailed with a due date of November 1. If you have paid both the first and second quarter amount with your first quarter payment you will not receive a bill for November. If you do not receive a second quarter bill, please check the bottom portion of your first quarter bill as your total bill may be too small to generate a second quarter bill.

If you pay into an escrow account with your mortgage holder when you make your mortgage payment, do NOT pay your real estate taxes on your residential property. The bank will pay it from the escrow account. If you have multiple parcels, please check with your bank as to which parcels they pay.

If you pay bills with a banking program, please be aware that there is a paper check generated that can take the bank over a week to mail so please plan ahead. It is imperative that you verify the bill number identifier you are using as a memo. Your bill numbers change every year for all types of taxes and your failure to correct the bill number causes difficulty in recording your payment. Please change the mailing address of the check so generated from the Woburn address, which is that of the lockbox, to the Town Collector's address which is PO Box 175, Shutesbury, MA 01072. Because your checks are not accompanied by a bill, the lockbox is unable to process the payment until I notify them of the type and number of the bill.

Please plan ahead when you mail your payments as it may take as much as a week to be delivered to any addressee.

If you do not feel comfortable coming into the Town Hall, you can drop off your payment in the drop box next to the driveway in front of the Town Hall. Please place the payment in an envelope addressed to the Collector. If you want a stamped receipt, please put a self-addressed, stamped envelope with the bill.

Do NOT postdate your checks! I cannot accept such checks because they cannot be processed until the date on the check. They will be returned to you upon receipt.

"Why is the name of the previous owner still on my real estate tax bill?" is a question we are frequently asked. Under Mass. General Laws, the name of the person who owned property on January 1 of the year in which the fiscal year begins must appear on all bills for fiscal 2024. In the case of this fiscal year (2025) that date is January 1, 2024. We highlight the "in care of" designation to make certain the bill is delivered to the new owner and not forwarded to the previous owner.

If you will be receiving your mail at a different address during the winter, please

notify this office when you will be leaving so I can redirect your bills and ensure that they will be delivered promptly. Please make certain I have your alternate address.

This is also the time to **verify** all information on your auto registration, license and insurance documents. Your insurance company furnishes information to the Registry of Motor Vehicles during the last guarter of the calendar year that provides the database from which your motor vehicle excise tax bills on vehicles reqistered on January 1 are generated. It is essential that the place of garaging and both the mailing and residential addresses are absolutely correct to insure proper and prompt delivery of your bills.

If you have an Amherst mailing address, that address should appear as the "mailing address" on your registration so it appears on your excise bill. Shutesbury must appear on your "place of garaging" so the tax bill is issued by Shutesbury for collection. Failure to have the correct mailing address may cause the bill to be returned as undeliverable and delays delivery.

Let me remind you that any tax bill sent from this office should *not* be ignored even if it is on property or automobiles you no longer own. The Town does not get notified if you dispose of an automobile, turn in your license plates, or dispose of personal property. You must notify the Board of Assessors by completing the appropriate abatement application.

If you move from Shutesbury, please leave a forwarding address and make certain you change your license and registration to indicate your new address and place of garaging. Any registration that lists Shutesbury as a place of garaging will result in an excise tax bill being sent from Shutesbury.

Remember, your unpaid excise bills from any municipality will follow you through the data base at the Registry of Motor Vehicles and its compact with other states. Unpaid bills can result in your inability to register a vehicle or renew your driver's license and registration.

Landlords mwith fewer than 10 units may be eligible for a 3% name loan for a tenant who has a functional limitation. Work on the site began gradually, with trailers for the construction management staff and storage delivered at the end of July and early August.

Erosion controls were then installed and inspected by the Conservation Commission, followed by the clearing of trees and topsoil.

In September, the foundation and footings were excavated, forms were built and concrete was poured.

Additionally, members of the Library Building Committee attended the MHEC Expo to explore furniture and shelving options.

As of this writing, we are awaiting the connection of temporary power to the trailers.

Next steps will include the in-🛍 stallation of perimeter drainage, underground plumbing, and electricity. In November and December, the contractor will focus on framing, roofing, windows, and temporary heating, which will allow interior construction to progess as winter sets in.

Developmental Screenings for 3, 4 & 5 Year Olds

In Shutesbury, developmental screening is available through the school as a first step in a process intended to find children in need of special services and to plan for meeting those needs. Screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/ language development and concept development.

This activity takes about 40 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.


