# 5. A motion was made and seconded to approve a Form CL-9, Release of Classified Chapter 61B Recreational Land Tax for Chairman Shpetner's notarized signature and member signature stamps, as

<u>recommended by Administrative Assessor Burgess</u>: ZW-16 located at January Hills RD, 46.49 acres. No rollover taxes are due; there is no right of first refusal for the town.

- 6. A motion was made and seconded to approve 5 Chapter 61B certificates as recommended for approval by Administrative Assessor Burgess: Arvanitis aye, Stein aye, Shpetner aye.
- 7. Personal property taxes on farm animals: Administrative Assessor David Burgess said that for purposes of assessing consistency throughout the town, he recommended Assessors formally vote not to assess backyard pets of undetermined value. The category, found only on the business form of list, is directed at larger-scale stables with million-dollar horses. The practice of taxing farm-animals dates back centuries when horses were tools and transportation, and chickens, goats, and cloven-hoofed animals were valuable farm products. To track down and value backyard horses, cloven-hoofed animals and fowl in Shutesbury in this century does not produce enough tax income to justify the assessing time involved. He added that by formalizing the decision, Shutesbury would be aligning itself with other towns in this area. A motion was made and seconded not to assess small farm animals in Shutesbury: Arvanitis aye, Stein aye, Shpetner aye.
