- National grid- 5/11 invoices
 - Not itemized amounts for the poles- no way to make an informed decision about expensive poles. Gayle has asked for an itemized list.
 - O Graeme/Gayle/WG&E- don't just pay the invoices; wait to get to see what poles we are paying for and see what other options there are. Poles could be out of spec and then they would be on the hook to pay for replacement. Due date is April so we have time.
 - Rick Durant (pole agent) will use the Verizon apps to see poles tagged for full replacement and will evaluate them.
 - \$8K to fix poles, \$2K to put up a new pole. To put up a new pole you need to notify company near the pole and the abutters 7 days ahead and it becomes a public process.
