- 6. Update on community housing partnership with Leverett Rita and Matteo met with 2 members of Leverett CPC and Shelly Garring of Massachusetts Housing Project. Leverett has approximately \$300,000 in their fund that they haven't been able to use in the recent past—they have offered housing assistance to individuals in the past but housing has now gotten too expensive to be able to actually offer it. They wanted to cooperate with us and focus on new construction and home ownership on publicly owned sites. First step would be for each community to explore what land they had available. MHP would offer money to help explore potential sites.
