  - a. Cemetery commission -Millinger— should we put off our application for another year? Response no reason to wait, this is not a competitive process.
  - b. Fernandez O'Brien interested in a project on the Bennett House and the property of the Carroll home. Renovate the house, use it for housing for people with disabilities and have the property turned into gardens. Any comments?

Response – must have public access, community garden may fit that. Because it has been stripped of historical details, the application would have to be for the housing component not historical preservation. It would come under the community housing component. – there are resources out there for assisted living, affordable housing. Farrell – feasibility study is necessary, suggested talking off-line.

c. Maffei – Subduing Knotweed coalition wants the town to apply for money for an expert to create a knotweed remediation plan.

Response – it's a common use of CPA funding. Who would be responsible for it in the town? Open Space, Board of Health, Planning Board or Conservation Commission could be sponsors. Can put in the DOE without all the details including who would be sponsoring this plan.

d. Pickelball players – wanted to know if the commission had any questions.

Response – Farrell – site identification, site analysis and feasibility study are missing. These shouldn't be combined with the actual creation of the courts. Pangallo said feasibility study would be eligible for funding. – this is a large sum of money (\$98K) that we wouldn't know would actually be able to be built. If you make this a 2-year project you could do the feasibility the first year and then the construction the second year (while also looking for matching funding).
