Report on Stretch codes (Heard)

- State Building Code is reviewed every three years regarding energy efficiency, e.g., tightness of building envelope, etc.
- State has issued a more stringent Specialized ("Net Zero") Code aimed at new home construction or major renovation for towns to adopt by approval at Annual Town Meeting.
- Heard proposes that ECAC do 'homework' on the new <u>Specialized Stretch</u> <u>Code</u> and provide an opportunity to educate Town and promote incentives toward energy-efficiency.

Reviving our workgroup discussions (DeFant)

- Can we carve out a path that doesn't require grant-writing?
- Instead of internal discussion, prepare topics to engage/educate Town residents relationship of particulars to overarching climate change
- Topic possibilities:
 - o Invasive species in *altered eco-system under pressure from climate change*, e.g., wooly adelgid making stands of hemlock fire-ready

• Stormwater *management in light of climate change* renews need for public education re homeowner management of runoff from driveways, slopes, etc.
