Permission to get estimates on PV installs for town buildings

Planning solar panel installations for town buildings requires learning whether it would cost money to gain a project estimate. The Finance Committee suggested that a specific project with an attached dollar amount could provide the basis for a discussion on funding. With a project estimate in hand, ECAC could have a productive conversation with the Finance Committee, possibly with good timing for a fall Green Communities grant cycle.

Community Choice Aggregation status

Nate wrote a two-pager for the Selectboard that communicates ECAC's recommendation of Colonial Power Group to be Shutesbury's CCA consultant. The document summarizes ECAC's reasoning and includes testimonials from people in neighboring towns that have worked with Colonial.

Electric car charger status

At 5:30, Selectboard member Eric Stocker joined the meeting. Livingston Energy approached Shutesbury about installing electric vehicle chargers at little to no cost to the town. However National Grid has published a list of many contractors that provide this service and Livingston Energy is but one of them.

Isaac will collaborate with Eric Stoker on a list of questions with which we can approach EV charging station vendors about services they might provide the town. Gail will review the list of qualified vendors to get contact information and to see if there are obvious ways we might narrow the selection.
