- 1) Approve minutes from March 23, 2017 and April 4, 2017 as amended with emails attached.
- 2) Budget Changes:
  - a) Cut OPEB line item by \$10,000
  - b) Reduce the Elementary School Budget by \$14,000. Discussion: Becky: We do not have authority over those funds, so it's inappropriate for us to remove it from the budget.
  - c) All is good with changes
- 3) Motion passed unanimously to modify the SES school budget line item 103 to a flat 2 %; \$1,938,324, funding their third request by \$10,500 less than requested.
- 4) Energy line 168: It funded all the new lighting, insulation. Now they want to build a 300KW farm it would offset all the town's electricity costs. Eric: Does not want to put funds aside for a potential solar farm.
- 5) Motion passed unanimously to defund the energy line item 178 for the upcoming fiscal year.
- 6) Library Income Grant line item 29. It is an accounting change.
- 7) Discussion about Police wages line 79. We will talk to Tom about the \$2,000 and a discussion about wages.
- 8) Capital Planning items
  - a) Sidewalk We had a lengthy discussion and decided to stay with the motion we made last week.
  - b) Paving We reviewed the three options again and Tim's recommendation. We confirmed our decision to put off the paving until another year.
- 9) Motion passed unanimously to transfer \$2,296 from Finance committee Reserves to cover excessive expenses in the legal line item number 38 to cover a law suit
- 10) Motion passed unanimously to transfer \$5,000 from Finance committee Reserves to cover expenses in the legal line item number 38.
- 11) Committee Reports
  - a) Broadband Report Eric: The state has said they will give us the grant money, about \$940,000. They have started a grant application, which will hopefully go out next week after the select board signs the application.
  - b) Visioning Committee Bob They are still working on a report
