- 1. The Minutes from the June 19, 2021, meeting were approved.
- 2. Status of Select Board's December 5<sup>th</sup> letter and May 18, 2021 follow-up letter regarding a request for the formation of a storm-water runoff committee.

There is still a need to reconcile the misunderstanding between the desire to preserve the lake and the perceived inability of the town to provide monetary support to reduce storm water runoff into the lake. The committee feels that a meeting with the Select Board is needed to discuss available options. Mark will speak with Becky about getting onto the SB agenda and send Eric copies of the storm water committee formation request

3. Update on Locks Pond Road culvert and dam valve repair.

Mark will follow up with Becky regarding the project plan for the culvert replacement and will provide an update at the August 14th Lake Wyola Association meeting.

Walter to contact Morris Root for information related to repairing the minor leak around the gate valve and schedule the next dam inspection.

4. North Cove Up-Stream Remediation

Terry suggested that we contact the Massachusetts Division of Ecological Restoration (DER) to see if they can provide technical expertise. Dave will try to make contact with them to see if they can help with developing an up-stream remediation plan.

5. Randall Road Boat Ramp

The committee wants to look again into obtaining state funding to improve the boat ramp and parking lot. Mark will send a copy of the proposed Land Management Agreement to Eric.

6. Review of recent *E.coli* test data
