Shutesbury Board of Selectmen Meeting Minutes June 24, 2014

<u>Members present</u>: Chairwoman Elaine Puleo and members Al Springer and April Stein. <u>Members Absent</u>: None.

Remote participation: None.

<u>Staff present:</u> Town Administrator Rebecca Torres, Administrative Secretary Leslie Bracebridge. **Press present:** None.

Guests Present: Oliver Waldman, Sharon Waldman and their 2 children waited in the hallway.

Chairman Puleo opened the meeting at 6:30 P.M. at the Shutesbury Town Hall.

Appointments

1. Being an alternate meeting week for the Board of Selectmen, Police Chief Harding was not present.

Topics

- 1. Gas Leak/Fire Station: No updates.
- 2. Salt Legal Issue/Possible Executive Session: No updates.

Select Board Action Items

- 1. Selectmen unanimously voted to approve the June 3, 2014 meeting minutes as written.
- 2. Selectmen reviewed and unanimously voted to approve the FY 15 list of appointed officials as prepared by Leslie, with the understanding that changes may occur as more feedback is provided by departments. The approved list is attached to the end of these minutes.
- 3. Selectmen unanimously approved and signed Personnel Action Forms for FY 15.
- 4. Selectmen unanimously voted to appoint Becky Torres and Daniel Hayes as Shutesbury's representatives to the Regional Assessment Planning Working Group: Becky since she is familiar with the on-going discussion and Dan Hayes, because he did all the research on this. If Dan declines, then Selectmen will appoint a Finance Committee member. Elaine and Becky stated that the "Working Group" is not a committee as defined by Open Meeting Law, but they are following Open Meeting Law.

Topics the Chairman Could Not Reasonably Have Anticipated

- 1. The Waldman family of 527 West Pelham RD came to the Board of Selectmen regarding a dog attacking another family in their neighborhood. They reported:
 - They have left messages, but have not hear back from the Dog Officer.
 - The Waldman's did not see the event. They report hearing about it. Their understanding is that:
 i. The attacking dog knocked a terrier down, then jumped up on the man (Jeff Quackenbush)
 - walking the terrier, and then attacked and knocked over his wife Mary Jo Maffei.
 - ii. Mary Jo has had 2 surgeries and is in a cast.
 - iii. The owner of the attacking dog was chasing his dog.
 - The Waldmans have become very concerned about the safety of their children and other neighborhood children. They request the dog be removed from Shutesbury.
 - The Waldmans understand that the dog is a rescue animal.
 - Chairman Puleo suggests a dog hearing to find out what is happening with the dog.
 - Becky: The quarantine is up. This story is different from what she has been told. Becky is getting multiple stories from multiple people. The Chief was not scheduled to be in tonight. Sgt. Masiuk responded. Dog Officer was not on scene. Becky wants a first-hand account.

- From what Becky understands, the attacking dog's owner has contacted the rescue organization and is trying to place the dog elsewhere. The Dog Officer has worked with the dog.
- The Waldmans state that they are asking the Select Board for a public hearing.
- Sharon Waldman: "We want the dog off the street."
- Sharon reports having read the statute: We're asking for removal or humane euthanization.
- The Waldman's offer to bring Jeff Quackenbush to a hearing.
- Waldmans: The fact is that 2 adults and a dog were mauled on a public street. We want a hearing. This is a Select Board decision.
- April: There were bites. We really need to hear from the people.
- Sharon: That's why we have been asking for a hearing. We know of other neighboring parents of children who want a hearing. We have 2 children living within 50 feet of a dog mauling. Sharon repeats that she wants a dog hearing and an analysis of whether or not the dog should be euthanized or removed.
- Sharon requests a police report. A police report is a public document.
- Al Springer states that he is not a fan of removal because it is just starting the whole situation all over again.
- Sharon reports the statute lists 5 possible things to do. People recoil at euthanizing an animal and Sharon agrees that it is "heart-breaking." She counters: It is not worth having that happen again and kill a child. Sharon has never seen the dog before.
- Oliver says at least it would be a courtesy for the Dog Officer to call back. T should be part of her job description.
- Al Springer wants information from Chief Harding and the Quackenbush family.
- Sharon responds that all of that information would come out at a hearing.
- Sharon worries if the dog gets out again; \$100,000 will not replace a child.
- Oliver: My responsibility is to represent my family. I am looking at my home and 2 kids. Two doors down is a dog that can take on and damage adults. In a month's time he has not gotten requested information from the police or the dog officer, or a decision to hold a dog hearing. He states, "I want that addressed by the Select Board."
- April confirms the need to meet with the Police Chief, the Dog Officer, and all parties. This is a public thing. There are 6 elementary school children right on the street who get on the bus every morning.
- Oliver would like that process.
- Elaine: Doesn't want to start process without information. Selectmen usually meet with the Dog Officer and the Police Chief, when a party complains. Elaine doesn't know enough about this. She confirms it is very serious: "I have a horrible fear of dogs." She asks, "How long has the dog been there?" Elaine states that she needs more information.
- Becky reports that the Police Chief has had emergency issues. He should be back by Friday.
- Becky: The Dog Officer immediately put the dog in quarantine, and visited the dog a number of times. A request has been put in to put the dog in a less populated area. There are limits to the quarantine. The expectation is that the dog be on leash at all times and never leave the property.
- The next Select Board meeting is July 15th.
- Becky: We can put information together and members of the Board of Selectmen can individually give feedback for a July 15 dog hearing.
- Elaine confirms: Put the information together and send it to all 4 selectmen. Elaine will visit the Chief the week of the 7th and make a decision. It's possible the dog will be gone by then.
- Al: Requests feedback from the owners on how the placement is going.

- Becky offers that the Dog Officer will call them tonight. A hearing notice goes to all abutters and Becky will also notify the Waldmans.
- The Waldmans offer to put the details of the event in writing. Elaine reports that the Secretary will capture tonight's meeting in detail.
- Leslie (minutes recorder) doesn't feel that Waldmans should rely on what she records.
- April: It's our responsibility to pull it altogether.
- The Waldmans thank the Board for their time and report their gratitude for the open meeting.
- 2. Selectmen unanimously voted to sign the Commonwealth of Massachusetts Operational Services Division State Agency for Federal Surplus Property Application for Eligibility as prepared by Fire Chief Walter Tibbetts with input from the Select Board and town resident Geoffrey Rogers. (See also Select Board meeting minutes of June 17, 2014.
- 3. Selectmen unanimously voted to sign a statement authorizing the Franklin Regional Council of Governments to contract on behalf of the Town of Shutesbury in the Franklin Regional Cooperative Highway Products and Services Bids and Contracts for FY 2015. (See also Select Board meeting minutes from the June 10, 2014, 7:30 AM meeting.)
- 4. On this, his final meeting as a Selectman, Elaine brought a blueberry rhubarb pie to honor the 6 years that Al Springer served on the Board of Selectmen. Selectmen reminisced about times they had shared together and with other public officials over the years.
