WINTER USE OF LAKE WYOLA BY-LAY COMMITTEE MEETING, Monday, March 15, 6:30pm at the town hall. The Selectboard has appointed a committee to create a bylaw for winter use of Lake Wyola to bring to the May 1, 2010 Annual Town Meeting.

FIRE STATION GASOLINE LEAK – Chief Walter Tibbetts and I walked the wetland site by the fire station on Thursday. The snow is slowly melting away. The booms and pads that are there to absorb the contimaninated soil were still frozen in place. Chief Tibbetts added new booms in preparation for the weekend's rain. The drinking water samples from homes near the fires station have come back negative for VOCs (volatile organic compounds). We are still waiting on the results of the long term air quality tests. On Friday, March 19, the Selectboard, Chief Tibbetts and myself will be meeting with DEP in Springfield, along with our LSP, Jim Okun, to develop a scope of work. A second tank was not found.

BUDGET AND FINANCE 2010

The police department's SUV is soon in need of replacement, according to our local auto repair experts at ESP. The Selectboard has discussed the issue and will wait for feed back from Capital Planning and Finance Committee the week after next on how best to proceed. There is no community policing grant money this year from the state. And the chief just received notice that the Highway Safety Division's budget is down so they will not be awarding \$3000 they had hoped to award earlier in the year.

SCHOOL COMMITTEE/SELECTBOARD Meeting rescheduled for 3/18/10, 9:00pm, Thursday night at the school committee meeting at the school. The meeting is to discuss the formation and charge of a committee "to engage in reflection of educational goals and to explore options." The Selectboard and School Committee want this committee to be a broad based representative body to take on the challenges of research, public discussion, brainstorming, evaluation, and reporting of educational options.

There is renewed talk at the state level for towns to create new efficiencies through new collaborations. It is important for the town to explore these issues before directives come from the state and we are caught without having researched and discussed these issues as a community. There are many cost efficiencies and educational benefits in being a part of Union 28. We have a solid baseline for comparison while reviewing these issues.
