New zoning districts proposed for Shutesbury

Shutesbury's Master Plan of 2004 recommends a number of changes in the Town's Zoning Bylaw to implement the plan's goals, some of which are:

- o managed growth in the most appropriate locations;
- o retention of rural character;
- o protection of the environment, particularly forest resources;
- o more affordable and diverse housing opportunities;
- o a more vital town center, and
- o continued home occupation and commercial opportunities for residents.

More recently, the Planning Board sent a survey to all households in Town asking detailed questions about possible zoning changes. In addition to incorporating this input, the Planning Board will hold a number of workshops for residents and meetings with town boards in the upcoming months, and will be discussing the new zoning proposals at its regular meetings on the second and fourth Wednesdays at 7:00pm in the Town Hall (all are welcome).

This community process will produce a new zoning bylaw, which will be on the warrant at a future Town Meeting. The most striking difference

in the proposed bylaw is the creation of four new zoning districts from the one we now have.

The proposed districts as of this date are:

Forest Conservation (FC): (most interior land beginning 500 feet back from town roads)

The purpose of the Forest Conservation District is to preserve large areas of interior forestland in order to maintain forestry as a viable industry and to protect watersheds, recreational land, natural resources, and wildlife habitat. The FC District is

Voters, 418 people cast ballots at the
May 6, 2006 Annual Town Election.

We welcome **Ralph Armstrong**
back to the Board of Selectmen after
a year's absence. We also welcome
officials elected for the first time in
Shutesbury: **Joanne Sunshower** to
the Planning Board and **Daniel
Greenberg** to the School Committee.

We are honored to have the
remaining elected incumbents return

Dihmann**; Library Trustee - **Clifton
Read**; Planning Board - **James

Please remember to **re-license your
dog for July 1**. You may use the
mail-in license application form sent
with this newsletter or come to the
Town Clerk's office in person to
license your dog.

State law requires proof of a cur-
rent rabies vaccination at the time of
licensing. We have previous license
records if your dog is "in-between"
vaccination years. If in doubt, call
your dog's veterinarian or call us to
make sure we have a current vaccina-
tion record. License fees are \$5 for
spayed and neutered dogs, and \$10
for animals able to propagate. There
is a late fine of \$5 to owners of dogs
who have not re-licensed by July 30.

We have **certified many nomination
papers and petitions** recently. It's a
pleasure to see that people are both
signing and printing their names on
these papers. In order to be counted,
signatures must be legible (or also
printed) and accompanied by a street
address (not a P.O. Box). Thank you,
if you are one who also prints your

name when you sign petitions and
nomination papers.

In anticipation of the September 19
state primary, **the last day to register
to vote** (if you are new to Shutesbury,
or have not previously registered) is
August 30. Call anytime to check
your voter registration status and/or to
have a mail-in registration form sent
to you. You can also stop in at the
town clerk's office anytime to register
to vote in person.

Absentee ballots will be available
approximately four weeks in advance
of the election for people unable to
vote in person due to absence from
town on election day, a physical dis-
ability or a religious belief that pro-
hibits being able to vote in person.

Absentee ballot application forms
can be sent to voters, or voters can
stop at the Town Clerk's Office and
vote in person through noon on the
day before the election. Voters can
also just write a simple request for an
absentee ballot to be sent, which
includes the voter's name, signature,
legal voting address, and where the
absentee ballot should be mailed.

If you would like to **become a paid
election worker**, please call the Town
Clerk's office before August to be con-
sidered for appointment for the com-
ing year. People who would be able
to begin work at 6:45am for the
September 19 state primary and/or
the November 7 election are
especially needed.

**All committees hold public
meetings**, which are posted at the
Town Hall at least 48 hours in
advance (and may also be posted at
www.shutesbury.org). Shutesbury
residents are encouraged to attend
meetings, ask questions and share
ideas with the people elected and
appointed to serve them. Contact
numbers for many committees are list-
ed on the back of this newsletter if
you would like to call ahead, learn
more about a committee's work or
offer an idea. Becoming involved in
meetings offers new friendships and
also ownership in the decisions that
affect our town government.

It's tax bill time again

Dear Shutesbury taxpayers,

Happy New (Fiscal) Year! With the
beginning of the new fiscal year, you
will be receiving the first quarter real
estate tax bill for Fiscal 2007. The
amount of the bill is approximately
25% of last year's total bill. Any
exemption you were granted in FY 06
will be reflected in the third and fourth
quarter bills for FY 07. Please
remember the following mailing and
due dates for your FY 07 real estate
and personal property taxbills:

Mailed on or before:

June 30, 2006

Due: August 1, 2006

Mailed on or before:

September 30, 2006

Due: November 1, 2006

Mailed on or before:

December 31, 2006

Due: February 1, 2007

Mailed on or before:

March 31, 2007

Due: May 1, 2007

If the payment for your bill is received
after the due date, the interest that
accrued will be reflected on the next
bill except for the bill due May 1,
which will result in a letter followed by
a demand notice with the extra fee
and interest. Therefore, it is very
important that you plan ahead and
mail your payment in time to arrive by
the due date.

There's a lot going on at Town Hall

As always, Shutesbury is in the midst of a wide variety of activity.

The **Library Accessibility Committee** finished its charge to design a plan for making the library handicapped accessible. Town Meeting approved the funding. The work will now be handed over to the Buildings Committee to oversee the construction and implementation phase.

In addition, the Buildings Committee is also working with the **Library Trustees** on their other needed building repairs.

The **Leverett/Cooleyville/Prescott Road** design work is nearing completion, with the project hopefully going out to bid the end of July.

The **Energy Committee** has completed its first clean energy project, a photovoltaic (solar) project for the elementary school. The installation is scheduled for early this summer. The solar panel project will have an important educational component for the children. This project is paid for by grants and our active participation in the Green-up program.

The Energy Committee is also determining the feasibility of a second clean energy project, a Wind Turbine, to be located behind Town Hall.

The **Select Board** is actively discussing the Community Preservation Act (CPA). We have a Community Preservation CD-R available if anyone would like to borrow the disk.

The **Conservation Commission** is about to hire its first part-time clerk.

The **Planning Board** is working on drafting new zoning bylaws.

Town Hall will soon become a possible shelter during natural disasters with the installation of a new generator.

If these projects do not interest you, but you would like to become involved in our town, call me at 259-1214. We will find something that fits.

Buildings Committee is keeping busy!

The Shutesbury Buildings Committee was re-established in late 2004 for the purpose of addressing pressing building problems. The Old Town Hall and fire station roofs were leaking badly. Also, portions of the fire station were in disrepair, and some building elements were never finished. These projects were successfully completed in 2005, as well as a long-standing structural defect in the Elementary School gym roof.

This year our committee is continuing with the same approach, which is to insure that our existing buildings will work well into the foreseeable future.

The Old Town Hall, fire station and parts of the Town Hall will be painted very soon. The design of the library access and bathroom project is moving forward and should be put out to bid around the end of June. Painting and repairs on the existing library building are also planned.

In addition, we hope to improve the insulation at the fire station and the two town halls as the heating costs are steadily escalating.

The next large project centers on improving the facilities at the highway department. The original garage, built in 1972, has roof leaks and is generally rusting. In addition, the facility does not fully comply with DEP regulations concerning hazardous material storage. Therefore a proposal will be made to re-roof and re-side the existing main garage and to connect (with a small addition) the main building with the rear garage. This will relieve cramped working conditions and create proper containment areas.

Another aspect will be to build a 20' x 40' addition to the rear garage to store the salt substitute now being used during the winter months.

New issues are always popping up and questions or suggestions are welcomed.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. This should be done as soon as you receive the bill so the bill can be adjusted promptly. However, you should always pay the bill and then apply for the abatement.

Since all fees and interest become part of the bill when issued, an abatement of part of the bill will still require you to pay any fees or interest that have accrued prior to payment. You will need to supply the Assessors with a bill of sale and a copy of a plate return receipt from the Registry of Motor Vehicles or a copy of a new registration for the same license plate to obtain the abatement. The abatement application is available on the Town's web site.

If you wish to pay your bill in person, please call the office first at 259-1615 to check my office hours.

To drop of payments, there is a locked box outside my office door. If you want a receipt, please enclose a self-addressed, stamped envelope.

Environmental Benefits:

- Generate less waste for disposal
- Reduce greenhouse gases
- Reduce industrial consumption of energy and water. (Production from raw materials, such as aluminum or glass, requires large amounts of electricity and fossil fuels.)
- Improve soil with household composting
- Keep toxic substances out of the waste stream by taking advantage of Household Hazardous Waste Day (at Amherst Transfer Station, pre-registration required)
- Reduce costs when new products are produced from reused or recycled materials.
- Reduce the consumption of new raw materials.

Financial Benefits to the Town Residents:

- Curb-side recycling has resulted in a 33% reduction in solid waste.

Cans/bottles	52.82 tons
Un-recycled trash (costs \$70.00/ton for disposal)	358.71 tons

- Town receives back \$28.00/ton for recycled materials. (Minimum of \$15.67 is guaranteed until 2012). This resulted in the town receiving \$5,244.60 from Waste Management, Inc., of Houston, TX, our recycling provider.
- If paper, cans and bottles were **not** recycled, residents would have been required to pay an additional \$12, 642.60 for disposal (180.68 tons x \$70.00)
- Our recycling efforts in 2005 resulted in saving the residents of Shutesbury **\$17,887.20.**

also intended to protect substandard rural roads from the traffic that would result from overdevelopment on interior land. Limited development is allowed, but overall density (dwellings/land area) is proposed to be very low (10 acres per dwelling unit, five w/ bonuses or TDR). However, the development that occurs would be clustered in order to preserve the largest possible areas of open space (minimum of 80% required).

Roadside Residential (RR): (500 feet on both sides of town roads) The purpose of the Roadside Residential District is to maintain the Town's historic pattern of rural settlement (other than in the Town Center and at Lake Wyola), characterized by residences and small home-based businesses scattered along a loose network of roads.

This district allows the Town to continue to grow according to this historic pattern and helps to ensure that development occurs primarily on roads that have adequate capacity to carry additional traffic.

Lot sizes are proposed to remain the same as at present (90,000 square feet), but the frontage requirement along roads may be changed according to their condition (paved vs. unpaved). A site plan review process will help the Town work with developers of new multi-family lots to improve the placement of buildings, parking areas, yards, and driveways. Other strategies are being considered which could help to retain some undeveloped frontage along roadways.

Town Center (TC): (approx. Pelham Hill Rd. east to Cooleyville Rd, and north a distance along Wendell Rd.)

The purpose of the Town Center District is to enable the historic town center of Shutesbury to maintain its place as the true center of community activity; allow some new development at higher densities than permitted elsewhere; allow for different types of housing; and promote a centrally located mix of residential, commercial, civic, governmental, and recreational

uses to serve the local community. Lot size requirements are proposed to be reduced from 90,000 to 45,000 square feet (size of football field), frontage from 250 to 125 feet.

Lake Wyola (LW): (developed areas around Lake Wyola) The purpose of the Lake Wyola District is to allow landowners who own land in the vicinity of Lake Wyola to make reasonable use of their existing developed properties while protecting the water quality of the Lake. Only two changes are proposed: 1) property-line setbacks are proposed to be reduced for accessory structures like garages and sheds, and 2) a 50-foot building setback from the lake is proposed. Note: The purpose of the district is not to establish any occupancy limits.

HOW TO CONTACT TOWN OFFICIALS
