

# OUR TOWN

## The view from Boston

On the weekend of January 24, I went to the Mass Municipal Association conference in Boston. Hundreds of local officials from all parts of the Commonwealth attended speeches, workshops and a trade show. We listened, talked, learned, and shared ideas about how to make local government work better.

A futurist, Mike Walsh, was the keynote speaker. His blog, Disruptive Futures, is at [www.mike-walsh.com/blog](http://www.mike-walsh.com/blog). He urged us to embrace data-driven decision making. His book, *Futuretainment: Yesterday the World Changed, Now It's Your Turn*, is about the impact of the Internet.

The presentation slide he used for an example of innovation right here in Massachusetts was of the founding members of WIREDWEST.

You all created the Shutesbury Municipal Light Plant (MLP) at Town Meeting. Shutesbury MLP is a member of the WiredWest MLP Coop. For the last four years WiredWest has been searching for funding of our business model. This past fall the Mass Broadband Institute began partnering with WiredWest to build the last mile of fiber work.

Stop by Town Hall any Monday between 10am - Noon for coffee and refreshments in the Senior Lounge! Everyone is welcome.

And be sure to check out the lounge's winter and spring activities. You can read about them in the Council on Aging flyer included in this newsletter.

In December the Shutesbury Broadband Committee reported on their work comparing three models to bring broadband, fiber to the home, to Shutesbury. They researched and compared three models over the last six months. They put together a comparative analysis of the Leverett model, a private company proposal, and the MBI/WiredWest Municipal Light Plant Cooperative network proposal. They recommended the MBI/WiredWest Municipal Light Plant Cooperative network. The Select Board embraced their recommendation and signed a non-binding resolution with MBI/WiredWest. This means Shutesbury is now included in the engineering work for the new WiredWest network, along with 32 other towns.

The next two steps are outlined in this newsletter on page 3 by the Shutesbury Broadband Committee and on their webpage on Shutesbury.org

The new President of the Senate is our very own **State Senator Stan Rosenberg**. State Representative **Steve Kulik** is a part of House leadership. Shutesbury has responsive and hardworking representation in Boston. This should bode well for Shutesbury. Rosenberg and Kulik are strong supporters of the state IT bond bill, the funding of last mile, the

## Winter updates from your Select Board

Although you may be in the middle of shoveling or de-icing, let us remind you that Town Meeting is right

around the corner! – No really, it is. Once again, we are encouraging you to start becoming aware of the issues at hand and the decisions that will be made. This is a big year for some crucial decisions (both monetary and philosophical), and we hope you'll be informed.

The Select Board, Finance Committee and School Committee will do all they can to hold forums and information sessions in the next three months. Please make time to participate in these. When you drive by Town Hall at night or early Saturday morning and see the lights on, it's because both employees and volunteers are busy attending to the needs of your community. Here are a few of the items that we're working on:

**Item One of interest** The Broadband Committee has moved our community closer to being able to have broadband (high speed state-of-the-art Internet service). There will be a lot more information coming from this committee over the next weeks and months, and the community's input is extremely important and welcomed. *This will include deciding whether to make a major initial investment on the part of the town.* It is a complex issue. Many thanks to the Broadband Committee for their work – please come hear about the effort to bring Shutesbury into the 21<sup>st</sup> century with respect to communication.

**Item Two of interest** The town is being asked to decide on a proposal to regionalize our schools with Amherst, Pelham and Leverett at the pre-K to12 level. The proposal is **See Select Board, page 4**

An Annual Street List form, requesting the household census on January 1 of this year, should have been received at each Shutesbury household by the time you receive this newsletter. As required by state law, these forms should be completed and returned in the SASE within 10 days of receipt.

If your household did not receive a form, please call or email the Town Clerk's Office (413-259-1204, townclerk@shutesbury.org) and one will be sent to you right away. Returning the completed street list form keeps one's voter registration active, ensures one's continued receipt of municipal mailings, and verifies eligibility for the annual trash bag distribution list!

Shutesbury's Annual Town Meeting and Election of Officers will take place Saturday, May 2, 2015 at the Shutesbury Elementary School, 23 West Pelham Road. Polls will be open 8am – 2pm. The Town Meeting usually begins at 9am. Watch for the late April *Our Town* mailing for final town meeting and election details.

If you are not already registered to vote, and you wish to vote on May 2, you must do so by Saturday April 11. Though my office will be open at least from 2 to 4pm and 7 to 8pm on April 11, why wait for the last minute? You can register to vote anytime: in person at the town clerk's office or by mail. Mail-in voter registration cards are always tacked up in the outdoor bulletin board of Town Hall and inside Town Hall in the files by my door. Call if you would like a mail-in voter registration card sent to you. These cards can also be used if you have moved within the town, changed your name or if you wish to change your party affiliation.

Absentee ballots for the Annual Town Election will be available for voters who cannot come to the polls on May 2, due to health concerns, religious restrictions or because they

will be out of town between the hours of 8am and 2pm.

You (or your relative on your behalf) may apply for an absentee ballot in person, or just write to the Town Clerk, P.O. Box 264, Shutesbury, MA 01072 to request an absentee ballot be mailed to you. Your request must include your residential and mailing addresses and your signature. If you apply in person, you can choose to vote at that time or a ballot will be mailed to you.

Your census mailing contained a summary of the offices and positions that are known to be on the ballot as of this date. More positions may open up due to resignations. Should any of these positions interest you, please request a nomination form from this office. You need only collect 20 signatures for your name to appear on the ballot. Completed nomination forms must be returned to the town clerk by 5pm on Saturday, March 14.

People sometimes ask if they can get an absentee ballot for the Town Meeting Articles. Absentee ballots are strictly for the election of officials and any ballot questions. Town Meeting questions are voted only by those who can be present on the floor of Town Meeting after an open exchange of information.

I look forward to being of assistance during this up-coming Annual Election and Town Meeting season.

## Note from the Town Collector

Dear Shutesbury taxpayers,

With the winter upon us, the third quarter of our real estate bills have become due and the calendar 2015 motor vehicle excise bills for many vehicles registered on January 1 have been mailed. Additionally, excise bills on vehicles registered late in 2014 are billed during 2015. The year for which the bill is issued is found in the upper right hand corner of the bill.

If you receive a bill on a car you have traded or on which you have changed registrations, do NOT ignore the bill. The Board of Assessors should be contacted to obtain an application for abatement. The forms are also available on the Assessors' section of the Town's website. The mailing address for the Assessors is PO Box 264, Shutesbury.

Our on-line bill paying feature allows you to pay your tax bills either directly from your checking or savings account with a fee of \$.25 or with a credit card for a fee based on the amount of your transaction. To use this service, click on the Town's website and then on the announcement on the Home page.

For Real Estate and Personal Property taxes, you should enter 2015 for the year and just the bill number WITHOUT the RE or PP to enter the program.

For motor vehicle payments, enter the year and bill number which is found on the top, right side of your bill. You are now able to find your bill information by clicking on the

notation "Need help locating your bill" after you indicate what type of bill you wish to pay. You then enter your last name and mailing address and click on the bill information.

With changes in the postal service, it now can take as much as a week for mail to travel from point of mailing to the destination. PLEASE PLAN AHEAD when mailing your tax payments to avoid interest due to late payment. The date your payment is received in this office or by the lockbox is the date of payment for receipt purposes under Mass. General Law.

If you receive a demand notice, you should pay it immediately as you only have 14 days from the demand date to pay before the bill goes on warrant which results in a substantial increase in the fees.

If you have purchased your property after January 1, 2014, Massachusetts General Law requires that the previous owner's name remain on the real estate tax bill. Hence, your name will appear with an "in care of." There is nothing we can do to put the bill solely in your name.

The question has come up concerning the information found on the bills. All information is required either by Massachusetts General Law or by the Department of Revenue of the Commonwealth. The Town and this office have no discretion on the statements printed thereon.

Before venturing out to pay a bill in person, please call this office at 413-259-1615 to check the answering machine to determine if I will be here.

## Brush burning: What everyone should know

By the time you read this, we will be in "Brush Burning Season." The season runs from **January 15** through **May 1**. The hours for burning are from **10am to 4pm**. Yes that does mean that the fire cannot be started before 10am and must be extinguished by 4pm. This is for the burning of brush only. **The burning of stumps, logs, leaves, building materials and trash is prohibited.**

Fires are to be located at least 75 feet from any building, and are to be attended at all times by a person 18 years or older. You should have some means of extinguishing the fire on site. This could be a garden hose or buckets of water and a rake and/or shovel.

**You must obtain a permit to be able to lawfully burn brush.** Permits are good for one day only, so you must get a permit for each day that you want to burn on the day that you want to burn.

There are two ways that you can obtain a permit. **The preferred way is on line.** The web site that you want to go to is: [www.fcburnpermits.com](http://www.fcburnpermits.com) The online permits are available from 8:30am to 1pm on any day that burning will be allowed. If burning is not being allowed on any particular day, the website will inform you of this and not allow you to obtain a permit.

You will first come to a welcoming page that describes the brush burning rules and regulations. To get a permit, click on the "click here to apply for a permit" line. You will see two lists, one of the towns that are allowing burning that day, and one for those that are not.

Click on your town, "Shutesbury," and fill out the form. When you submit the form a record of the permit will go into the system and a copy of the permit will be emailed to you at your email address. Print this permit out and sign it. It should be kept with you while you are conducting your burning.

**For those of you without a computer or Internet access, do not worry!** You can still call our dispatch center Shelburne Control at

413-625-8200 to get your burning permit, just as you have been doing for the last several years. They will in turn enter the information into the system.

I do need to stress that the burning regulations are set by the Massachusetts Department of Environmental Protection (DEP) and not the Bureau of Fire Prevention. Therefore **days that seem safe for burning, such as those overcast with a light drizzle or rain, are considered bad days for burning in regards to air quality.** Warm, dry days with a light to moderate breeze are good days for air quality but may be hazardous for fire safety.

The air quality as determined by DEP is the first qualification for allowing burning or not. If the DEP determines that it is ok, they will allow us to issue permits.

On any day that the fire danger index reaches a "high class 3" day or higher, permits will not be issued due to the fire danger. This usually happens once we lose the snow cover, the surface fuels dry out, and before we get leaf cover or things start greening up. In these conditions there is a high risk of the fire getting out of control and spreading. **If this happens, don't delay, call 911 immediately.**

Please use care in starting your fires. Use a small amount of paper and kindling to start the fire if possible.

Using flammable liquids should be avoided because of the risk of personal injury. If you feel you must use an accelerant, use small amounts of kerosene.

**Never use gasoline to start the fire.** Make sure the area around your burn pile is free of leaves, long dry grass and any other readily flammable materials that would promote fire spread.

Also be courteous of your neighbors. Try to keep a clean-burning fire, producing as little smoke as possible and watch where your smoke is going. Remember: in Massachusetts brush burning is a privilege, not a right.

The Shutesbury Broadband Committee has had a tremendously busy year since we started meeting in April.

We are pleased to announce that we've recommended that the Town of Shutesbury adopt and support the Wired West Cooperative initiative to bring high-speed fiber optic Internet to our town.

The Wired West Cooperative in

partnership with the Massachusetts Broadband Institute (MBI) has made incredible progress this year to bring a solid and viable proposal for building a regional broadband network.

Our endorsement comes after nine months of careful data collection and deliberation.

We've analyzed three different plan models and chosen the one that we believe will bring broadband to Shutesbury in the most cost effective, equitable, minimum risk, high quality and expedient manner.

The Select Board endorsed the plan and we're working with the Finance Committee to present full

details for vote by Annual Town Meeting.

We'll be mailing out more information in February about the cost and timing for the project as well as the next action steps YOU as a potential broadband subscriber can take to move the project forward.

MBI/WiredWest fiber network and active participants shaping the state budget.

But the message from Boston at the MMA conference was that the state of the Massachusetts FY15 budget is not good, although the Massachusetts economy is strong. The Governor presents his FY16 budget in March. His administration is focusing on a shortfall of \$760 million in this current year, with only five months left in this fiscal year.

The outgoing Administration's projected deficit was \$329 million in the \$36 billion state budget. Gov. Patrick made \$250 million in 9c cuts and sent

a bill to the House to close the gap \$80 million. The \$80 million was not acted upon by the legislature.

The incoming Administration's projected deficit is \$760 million. The new Governor has identified the budget gap as a result of the Commonwealth's spending problem.

Governor Baker said in his speech at the MMA conference that he is committed to not raising taxes, not using any of the \$1.2 billion rainy-day reserve fund and not reducing Chapter 70 education aid or the Unrestricted General Government Aid (UGGA) to cities and towns. He also said he will not pass down unfunded mandates to the cities and towns. Like our local

town budget, much of the state budget is nondiscretionary.

Where are the cuts going to come from? How will they impact local services? The towns, the planning agencies and many non-profits depend on state grants. Outside of Chapter 70 and UGGA, local towns count on state funds for our libraries, for our schools, for veterans, payments in lieu of taxes for forest, and support from Franklin Regional Council of Governments.

As we start this new relationship with our new Governor, and new President of the Senate, we will all need to share our thoughts, concerns, priorities, with them as important decisions are made.

before the current Regional School Committee who will bring it forward to all four Town Meetings for a vote. This is the culmination of five years of work by the regionalization committee, of which we hope you have been staying aware. There will be forums in our town, as well as in neighboring communities, giving opportunity for input from all our citizens. The proposal is posted on the Shutesbury.org website. Please take the time to review, comment and think about this document. A tremendous amount of work has gone into it, and it is worth everyone's time to look at it. *The current timeline has us voting on the proposal to regionalize our schools at Town Meeting.* Even if you do not have children in the school system, this will impact you.

**In addition, our Planning Board is moving toward revising our 10-year-**

**old master plan.** This will be a long range project and will set the stage for future years' decision making. We hope to have a visioning process that will take EVERYONE'S viewpoint into consideration. If you want your ideas considered, you must come and be heard.

Small rural towns like Shutesbury have to raise most of our resources through property tax. We also have to provide the same services a larger town provides (schools, roads, government, police, fire, etc.).

Given our resources, careful planning and discussion is needed. Where Shutesbury should be going as a community is something we can all have a voice in. Meetings are posted, and input from community members is always welcome.

There is always a need to hear what residents of Shutesbury expect from its leadership. Come to commit-

tee and board meetings to offer your insight. Send emails via [@Shutesbury.org](mailto:@Shutesbury.org) and let us know what you are thinking.

Better yet, volunteer for a committee and take an active role in shaping our future. Just as a small town has a smaller base from which to generate taxes, we also have a small base from which we can seek volunteers to help with running the town. Any assistance you can provide goes a long way to making life better for all of us in town.

One of the great benefits of being in a small town is having a voice that really matters. Get involved, get active. You'll learn a tremendous amount along the way, meet new people and feel a great sense of accomplishment.

We urge you to be involved, communicate with the Select Board, attend our meetings.

## Shutesbury in 2025 — what will it be like?

The Planning Board (PB) has to answer this question and wants your help. State statute recommends that municipal planning boards develop a Master Plan (Plan) and update it periodically. Shutesbury's current Plan ([shutesbury.org/sites/default/files/offices\\_committees/planning\\_board/MasterPlan.pdf](http://shutesbury.org/sites/default/files/offices_committees/planning_board/MasterPlan.pdf)) was created by many residents 10 years ago, so it is time to work on an update.

The first key planning step is called "Visioning," which is a guided public process that solicits input from a cross section of residents to develop a set of goals and objectives for the town's next 10 years. The goals will identify the end targets and the objectives will clarify how to reach them. Key topics in town that are likely to draw strong opinions will be discussed.

Some issues that immediately come to mind are broadband, elementary school regionalization, library expansion, road conditions, fiscal constraints, and the Town's changing demographics. In addition to identifying the formative issues, residents will be asked to identify the barriers to addressing those issues, and suggest ways to overcome the barriers.

Several tasks need to be accomplished prior to the Visioning process beginning. The tasks include assessing the interest of various town committees and boards, requesting funding to hire a professional planner/facilitator to guide the Visioning process, forming a Master Plan steering committee comprised of a diverse group of residents, and getting townspeople involved in the discussion.

To date the Planning Board has met with the Library Trustees, Broadband Committee, Water Resources Committee, and Board of Selectmen to assess their interest. They have also worked closely with the Group for Civil Communication to advance



plans for the Visioning Process. Stay tuned for updates.

The CPC will be meeting with the applicants in open meeting on Thursday, February 19 at 6pm in the Town Hall.

In addition, a public hearing will be held on Thursday, March 19, from 6:30-8:30pm at the Shutesbury Elementary School library at 23 West Pelham Road.

Attendees will hear presentations, and have an opportunity to ask questions about the proposed community preservation projects.

Shutesbury's Conservation Commission and the Old Town Beach Improvement Committee (see Old Town Beach insert in this newsletter) have proposed separate recreation projects at Lake Wyola.

The Cemetery Commission and Shutesbury Athletic Club have each proposed historic preservation projects.

There will also be an opportunity to contribute, and to hear others' ideas about Shutesbury's community preservation needs, possibilities, and

resources. We encourage all to attend the public hearing and look forward to seeing you there.

## Pre-School and Kindergarten Screening offered for 3, 4 & 5 year olds in our community

Developmental screening is available through the school as a first step in a process intended to find children in need of special services and to plan for meeting those needs.

**This screening is available to all**

**families in town, including those with a child not already enrolled in the school's preschool program.**

The screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/language development and concept development.

This activity takes about 20 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of

## Union #28 Community Network for Children

The *Community Network for Children (CNC)* program is funded through the Massachusetts Department of Early Education and Care Coordinated Family and Community Engagement (CFCE) grant.

## Return it in Shutesbury!

The Massachusetts Library System operates a statewide delivery system for the transportation of library materials across the Commonwealth. Last year fourteen million books, audiobooks, magazines, DVDs and more traveled among Massachusetts libraries through this delivery service.

The M.N. Spear Memorial Library receives deliveries three times each week on Mondays, Tuesdays and Thursdays.

Last year Shutesbury library patrons received 4,260 inter-library-loan items, delivered through this service. Our library also provided 4,943 inter-library-loans to patrons at libraries in other Massachusetts towns.

An added convenience of this delivery service is the ability of Shutesbury library patrons to return items borrowed from any Massachusetts library here at the M.N. Spear Memorial Library. We place the items in our out-going delivery bins and they will be transported to the owning library – usually within a few days. Don't hesitate to return items borrowed at other libraries here if it is more convenient for you, we don't mind at all.

## STEAMRollin' at the SLEW Libraries

Preschool-aged children in Shutesbury, Leverett, Erving, Wendell, and surrounding communities are invited to join us for a year-long exploration of STEAM topics. Each library will offer a series of eight monthly programs exploring science, technology, engineering, art and math. Activity Stations at the libraries will encourage children and their families to ex-

plore these topics through creativity and play. Visit one of these four libraries to pick up a program calendar and to participate in fun, interactive programs and activities.
