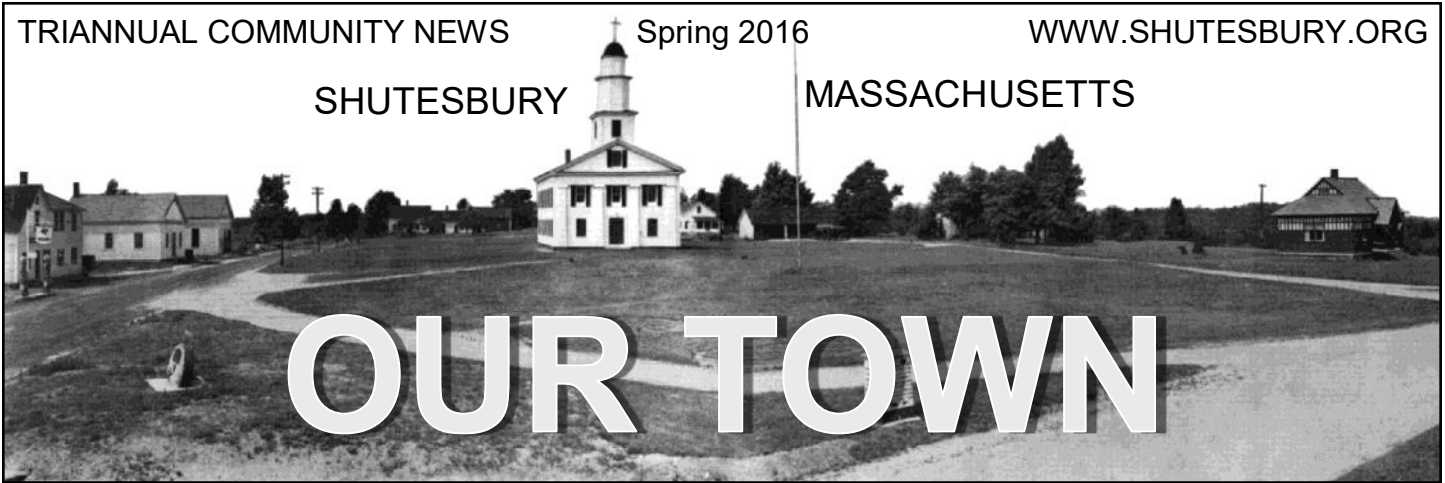

Town Meeting and more

Annual Town Meeting will be on Saturday, May 7, 2016. The meeting opens at 9:00am and runs until we finish. The Select Board and Finance Committee will hold an informational meeting on April 21 at 6:00pm, at which people are invited to ask questions about the budget and other items on the warrant.

Town Meeting is one of the oldest forms of democracy, and is the place for people to ask questions, get information and make decisions central to running our town.

Selectboard, Finance and School Committee representatives met on February 27 with representatives from the other three towns in the Regional School district. The towns, and the regional school committee, have agreed to use an assessment formula, for FY 2017, based, in part, on the recommendations developed by our town in the summer of 2016. This is a move to changing the method to include each town's ability to pay, rather than assessing a flat per-pupil cost for all four towns.

The change in the formula will save Shutesbury a modest amount this year.

The four towns have agreed to form a new committee to come up with recommendations for a fair assessment method that will begin in FY 2018.

The question of changing our regional agreement to possibly include pre-K through grade six, has been

tabled by the Regional School Committee. Expanding the region to include the younger children has been discussed and studied for over two decades. It remains a complicated issue and more discussion is warranted. Whether or not to combine the Middle and High Schools into one facility is being planned by the Regional School Committee, but will not occur in FY 2017.

Broadband . . . what's happening? Our town is fortunate to have a highly skilled and hardworking Broadband committee. The Select Board continues to support the WiredWest solution, while also remaining open to other possible ways of bringing fiber to Shutesbury.

Community Preservation projects to come before Annual Town Meeting

The Community Preservation Committee (CPC) voted unanimously on March 17, 2016, to recommend that Annual Town Meeting approve two proposed Community Preservation funded recreation projects. The detailed project proposals are on the CPC web page at Shutesbury.org. (see Offices & Committees)

Shutesbury Elementary School:

1. Restore the kindergarten playground and purchase an ADA accessible playground structure to create a playground space for young children including children with disabilities

\$29,000

2. Construct a multi-use track in the upper field that is usable and safe for many populations

\$5,000

And along with spring weather comes Annual Town Meeting (ATM) held at the Shutesbury Elementary School, 23 West Pelham Rd.

This community event is an opportunity to come out and see your neighbors, vote on the town warrant articles, cast a ballot to fill elected town positions, and get your trash bags.

Shutesbury's open **Town Meeting** is May 7, the first Saturday in May, starting at 9:00am. All registered voters **may vote in person on warrant articles** as each item is put before its members during Town Meeting. Town Meeting materials such as the warrant, budget, etc. will be mailed to every home and posted on the home page of the town website, www.shutesbury.org at least one week before Town Meeting.

Registered voters may also **cast a ballot at the town elections**. Polls open from 8am – 2pm. Election results will be posted on the town website. **Voter registration** for these events closes on Saturday, April 16. On that day I will be in the Town Clerk's office from 2 – 4pm and from 7 – 8pm. Write-In candidates must have a complete name and street address. Stickers with this information are accepted.

If you are going to be out of town that day, have a physical disability or will be absent due to a religious belief, you may cast an **absentee ballot** for candidates up for election. Applications for absentee ballots must be made in writing and include:

- the voter's name
- residential address
- the address to which the ballot should be mailed
- the voter's signature.

You may mail your request for an absentee ballot to: Town Clerk, PO Box 264, Shutesbury, MA 01072.

There are forms that request the same information available outside the Town Clerk's office and online on the town clerk's page, but a letter, or an email with a signature that has the information listed above will do. Please allow plenty of time for mailing materials back and forth.

You may also vote absentee in person at the Town Clerk's office until noon on Friday, May 6.

The Recycling and Solid Waste Committee begins its new year of **trash bag distribution** at Annual Town Meeting. The schedule for other distribution dates and recycling will be available at ATM and on the home page of the town website. So when you arrive, in no particular order, you can get your trash bags, sign in for a card for voting on Town

Meeting articles, and check-in to vote at the election.

Spring is also an opportune time to **license or re-license your dog** before the current license expires on July 1. Early birds can avoid a late fee by registering before August 1, 2016. Remember to check if the rabies vaccination is up to date. An application form is included in this mailing and is available on our Town website on the Town Clerk's page.

If you have any questions, my public office hours are Monday afternoon 3:30–6 pm, Tuesday–Friday mornings 8:30–10:30 am, and Tuesday evening 6 -8 pm. During the week I'm at work during other hours; please feel free to call and make an appointment if needed.

Connect the dots

The Second Roadside Community Clean Up Day is coming SATURDAY, APRIL 30 from 10:00am - Noon.

Some folks have already responded to the announcement in *Our Town* and on Next Door Shutesbury. We have volunteers from West Pelham, Locks Pond, Wendell, Cooleyville, and Baker Roads.

As we get more responses we'll connect the dots and share the network of families and friends who will pitch in to pick up the roadside trash all over Shutesbury.

We learned a bit from last year's success:

- It was easy, fun and rewarding - The more the merrier.
- Wear gloves and bright-colored clothing or borrow a safety vest from the Town Clerk's office.
- Use landscape tape to mark a big roadside item that won't fit in a trash bag. We'll organize volunteers in a pick-up truck to bring it to the dumpster at the Town Hall.
- Go up one side of a section of road, then cross and return along the other side.
- Folks can leave recycling bins at the end of the driveway to help collect recyclables picked up that day.
- Bring in the trash you collect and we'll swap you a new trash bag in return.
- We separated trash, recyclables and deposit bottles and cans at Town Hall last year.
- Volunteers with a pick-up truck were a big help.

This year we hope a few people will volunteer to bring a soup to Town Hall to serve to community friends that help.

Last year we had about 50 people and we covered most of the streets and areas such as the boat launching ramp. The schoolyard was cleaned by the 5th and 6th grade Student Council. This year we'd like to make connections on Pratt Corner, Weatherwood, and January Hills Rd.

Shutesbury Bulky Waste Day Saturday, June 4!

Saturday, June 4 is Bulky Waste Day (BWD) at the Highway Department from 10am to 2pm for Shutesbury residents. Bring items that are too large for the trash, such as construction waste, mattresses, electronics, etc., etc. We do charge enough to cover the cost of disposing of these items, so bring some cash or your check book. **DO NOT** bring hazardous waste or florescent bulbs to Bulky Waste Day.

Please give the RSWC a hand that day if you can. We could use some strong volunteers to help things run smoothly at BWD. We had several terrific volunteers for the October BWD last year, and their help made a huge difference. Many hands make light work! Please Note!

- ◇ TVs — CRTs and flatscreens — 32 inches or less will be \$20.00. TVs larger than 32 inches will be \$40.00. Computer monitors — CRTs and flatscreens — will be \$10.00. All other electronics are free.
- ◇ All clean, white Styrofoam will be collected at no cost.
- ◇ Bulky rigid plastics (see below) will be collected separately and recycled at the Materials Recovery Facility in Springfield. We will be charging between \$2 and \$5, depending upon the amount, to help cover the cost of the hauling.

Free by the Side of the Road

The week before each Bulky Waste Day is "Free-By-the-Side-of-the-Road Week." If you have items that you no longer need but might be useful to others, place them on the roadside during the week beginning Saturday May 28th.

NOTE: Items placed on the roadside that are NOT picked up before Bulky Waste Day must be removed at the end of the week. Put them in trash bags or bring them to Bulky Waste Day. In 2014 Town Meeting passed a "Littering and Dumping Bylaw" that addresses items left by the side of the road longer than two weeks. Note from the Town Collector

Dear Shutesbury taxpayers,

Happy spring! Now that the warmer weather is approaching, we are approaching the end of fiscal 2016 and the Town Meeting for fiscal 2017.

My office hours are Monday, Tuesday, Wednesday and Friday from 9:00am – Noon and Thursday from 8:00-11:00am. Should you need to see me and these times are inconvenient, please call and we can arrange a better time to meet.

Due to the time it takes for mail delivery, it is imperative that you PLAN ACCORDINGLY when mailing your payments. Under Mass. General Law, we do NOT use the postmark for date of payment but rather the date of actual receipt. You should mail bills at least ONE WEEK before they are due to insure that they are received before the due date.

If you use on-line banking from your bank (not the Town's system), please be aware that the bill will come to this office for processing from the lockbox because it is not accompanied by a copy of the bill. PLEASE make sure the memo information is correct and does not reflect information from previous payments (i.e.: listing real estate or excise bill numbers from previous years or an incorrect type of bill).

Since your bill payment is NOT an automatic transfer into the Town's bank account, you must PLAN ACCORDINGLY when authorizing the payment. DO NOT set up the payment on the due date, it won't get to

the Town until almost a week later which will result in fees and interest.

Your fourth quarter real estate taxes are due May 2. I urge you to pay these bills promptly as the next bill you will be receiving is a demand that will cost you an additional \$ 5.00 plus interest. If you need to set up a payment arrangement on your bill, please contact me as soon as possible. Although interest will accrue on any overdue portion of the bill, you will avoid the additional interest and any collection procedures beyond the demand that will accrue should you leave the entire bill unpaid.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. All bills should be paid in full before you apply for abatement. If this is not done and the bill becomes overdue with additional fees and interest before abatement, these must be paid along with any outstanding balance due on the bill after abatement.

Payment of all types of bills MUST be received on or before the due date which is clearly marked on the bill. Please make note of these dates and make your payments accordingly. Always open all envelopes you receive from this office immediately on receipt. The bill you think is a real estate bill (and paid by your bank) may be an excise tax bill for which you are responsible.

Be sure to notify this office if you change your mailing address to avoid a delay in delivery of your mail which is returned to me for forwarding. This can take as much as two weeks which reduces the time you have to pay the bill on time.

Should a demand bill be issued on a motor vehicle excise tax, the law provides 14 days for receipt of payment before a warrant for collection is issued to the Deputy Collector. This results in at least \$ 22.00 in additional fees. Upon mailing of the demand bills, payment of the original bill will NOT be accepted and checks made out in the incorrect amount WILL be returned to the sender.

Some of you have been unable to pay your bills on-line. Once a bill is overdue, it is automatically deleted from the system and can't be paid on-line until the demand is issued. If the bill is on warrant, it cannot be paid on-line except through the Deputy Collector.

Broadband update

This year has brought many changes and uncertainties to the "Last Mile" broadband project for Western Massachusetts. 2016 started with more than a half dozen meetings between the WiredWest Cooperative and the MBI (Massachusetts Broadband Institute), with both parties working hard to negotiate issues around ownership and the operating structure that were raised at the close of 2015. Shutesbury continues to be represented with two delegates as a member of the WiredWest Cooperative.

On February 4, Governor Charlie

Baker's administration put a pause on the release of state funds for broadband projects while his office conducted a review of many state funded programs (the Governor is in charge of managing the MBI). The pause was unrelated to WiredWest and the examination included all towns, even those who were considering building private networks. In mid-February, the director of the MBI resigned and the agency still remains under the leadership of an interim director.

On March 14 the Baker-Polito Administration with the MBI issued a joint letter to participating towns supporting the concept of "last mile" broadband projects. It stated that the current administration is still behind bringing broadband to Western MA, which we see as a positive development. It also stated that the MBI will support "projects where cost-effective and sustainable solutions are identified and access to financing is assured." The Governor charged the MBI with creating the criteria by which towns would be approved for funding, but no date was given for the release of these criteria. Currently, not one town in the state has received funding to move forward with any new fiber-to-the-home broadband project.

Unfortunately, all of the recent changes along with the lack of detailed communication from the MBI has left towns in Western MA with an uncertainty about the future of broadband. Because the MBI has yet to release the criteria by which projects will be approved for funding, all towns are left waiting. On March 21 Wired West released a status report detailing their continuing efforts, including possible revisions to the operating plan. Please visit our website (link below) to see these documents.

As a next step the WiredWest participating towns will work together to assert political pressure on our state leadership in a coordinated effort to move the project forward. The Broadband Committee will be working in partnership with our Select Board on this effort.

Contact the Conservation Commission BEFORE starting your project

By the Shutesbury Conservation Commission

Don't wait until your contractor is scheduled to contact us. With the arrival of warmer weather, many town residents start to think about construction or landscaping projects. New construction, tree removal, grading or excavation and almost any work done near Lake Wyola must be reviewed by the Commission before work begins. Keep in mind that the Conservation Commission must sign off on all Building Permit Applications whenever digging is required. At the minimum, a site visit is required prior to signing off. As a fully volunteer Commission, we often can't schedule a site visit for at least a week. And if wetlands are nearby, the process is more complex and takes several weeks.

Our knowledgeable clerk, **Linda Avis Scott**, is there to help you through the process. She can help you determine what you need to do and how to go about it. Here's how to start:

- 1) Leave a message on our answering machine at [413-259-3792](tel:413-259-3792) or email concom@shutesbury.org
- 2) Visit Town Hall during Scott's office hours: Tuesdays and Thursdays from 10am to 12 noon.
- 3) Attend one of our meetings (from March to October, on the 2nd and 4th Thursdays at 7:00pm and from November to February, on the 2nd Thursday). It's best to call first to get on our agenda.
- 4) For more information about the work of the Commission visit our webpage at www.shutesbury.org/concom

The applicant completed a detailed application and went through an extensive review process.

The CPC process began with the applicant completing preliminary Determination of Eligibility applications for each proposal. On December 3, 2015, Shutesbury's CPC — with members who represent the Select Board, Conservation Commission, Historical Commission, Community Housing, Open Space Committee, Finance Committee, Planning Board, and the community-at-large — determined that the two proposed projects are eligible to receive Community Preservation funds.

The applicant then prepared full applications with descriptions, specifications, and budgets for each project.

The CPC convened an open meet-

ing for an initial review and discussion of the proposals in January 2016.

At the February CPC meeting, the applicant presented its proposals and answered the CPC members' questions.

At the CPC's Annual Public Hearing on March 9, the applicant again presented and answered follow-up questions from the members of the committee and other interested Shutesbury residents, including students of the Shutesbury Elementary School.

After completing its review and evaluation process, the CPC members voted unanimously on March 17 to recommend funding both projects.

Each project is financially and administratively feasible, has other sources of funding, includes significant in-kind volunteer contributions, and has support from other town boards or committees.

Each project will provide a positive impact to the community and will take a step toward achieving long standing, but unfunded, priority goals for Shutesbury.

The total appropriation, should the Annual Town meeting approve both projects recommended by the Community Preservation Committee, is \$34,000. This will leave an increase of approximately \$13,700 in additional CPA town funds through June 30, 2017.

Shutesbury's Community Preservation Committee recommends that fellow community members attend Annual Town Meeting on Saturday, May 7, 2016, and approve Community Preservation funds to implement these two worthwhile recreation projects.

Attend fragrance-free! A growing number of people suffer severe and debilitating physical symptoms when they are exposed to scented personal care products. The most problematic substances are perfume, cologne, aftershaves, essential oils, fragranced gels/hairsprays, laundry detergent, and fabric softener. Please do not use scented personal care products on any day that you will be visiting a town building.

Developmental screening for 3, 4 and 5 year olds

Developmental screening is available through Shutesbury Elementary School as a first step in a process intended to find children in need of special services and to plan for meeting those needs.

The screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/language development and concept development. This activity takes about 40 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.

This screening is available to all families in town, including those with a child not already enrolled in the school's preschool.

Remember 2011, Shutesbury's 250th anniversary?

If you are new to Shutesbury bring a photo I.D. and proof of address to the library. It usually takes less than one day to process a new account.

C/W MARS

The Library is a member of C/W MARS, a consortium of about 145 libraries in Central and Western Massachusetts. This network membership gives Shutesbury Library patrons access to nearly nine million items, including books, audiobooks, DVDs, magazines and more, through inter-library loan. Every Shutesbury resident with a library card can access his or her own online library account to search the vast catalog.



Holds can be placed for items not available at the Spear and in most cases those holds will arrive within a week. We receive deliveries on Mondays, Tuesdays and Thursdays.

How to log in to your account

- Go to our website, mnspear.org
- Click on the **Log in to Your Account** tab

Enter your 14-digit library card number and your password.

If you don't know your password, first try your last name, all capital letters. Hold the shift key as you type the letters; the caps lock key will not work. If your last name doesn't work, you have two options. Use the online system to reset your password or call the library, 259-1213 for help.

To try to set or reset your password online:

- Click **Forgot Your Password** – this brings you to a page where you be asked to enter your library card number or user name.
- Click **Submit**

An email will be sent to the email address associated with your account with instructions to reset your password. We have noticed consid-

erable lag time between the time the request is sent and when the email arrives. We are always happy to help, don't hesitate to call or stop in.

Once in your account, you can place holds, view items checked out, renew items, manage account preferences, pay fees and more.

Check Out History

The Library does not maintain records of items patrons have borrowed, but patrons can choose to keep a *Check Out History* in their online account.

Follow the following steps to save your check out history.

- Log in to your account
- Click the *Account Preferences* tab
- Click the *Search and History Preferences* tab
- Check the *keep history of checked out items* box.
- Click **Save**

To view your check out history, click the *Items Checked Out* tab, then the *Check Out History* tab.

Downloadable Books

Shutesbury Library Patrons have access to free downloadable ebooks and audiobooks through Overdrive and Axis 360. To browse, borrow and download digital items, click on the *Digital Media & Books* tab on the home page of mnspear.org.

Most patrons will be interested in the items available through Overdrive and Axis 360. These platforms can be used with most computers, tablets, and smartphones. To get started, click on the *CW MARS* Overdrive help link or the Axis 360 help link.

You will have to download and install software or an app for your

reading or listening device. We have printed instructions available at the library if you have trouble navigating the online instructions.
