In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town, qualified to vote in elections and town affairs, to meet at **7:00 pm on Tuesday, 13<sup>th</sup> day of November** at the Shutesbury Town Hall at one Cooleyville Road in said Shutesbury, in the year Two Thousand and Twelve, then and there to act on the following articles:

**Article 1.** To see if the Town will vote to transfer \$96.98 from free cash to pay prior year bill for Assessors Expenses or take any other action relative thereto.

**Article 2.** To see if the town will vote to approve election of the Constable for a term of three years beginning with the 2013 Annual Town Election in accordance with MGL Chapter 41 Section 2 or take any other action thereto. *Selectboard Recommends*

**Article 5.** To see if the Town will vote to adopt the **<u>PROPOSED ZONING BYLAW</u>** <u>**AMENDMENTS TO CREATE FLOODPLAIN OVERLAY DISTRICT**</u> as written or take any other action relative thereto. **Selectboard Recommends**

**Article 6.** To see if the Town will vote to transfer from the surplus overlay account to the 2009 overlay account the sum of \$10,277.00 to repay Verizon for the 2009 overlay charges that have been relieved by the court or take any other action relative thereto.

**Article 7.** To see if the Town will vote to authorize the Selectboard to enter into a Multi-Year Solar Agreement contract of up to 25 years to act as a host customer for one or more solar projects in the Town of Shutesbury and to enter into an agreement with the local utility to participate in the Net Metering program pursuant to the Acts of 2008, c. 169, §78, the so-called Green Communities Act, as may be amended.
